6. Submission does not guarantee award. Selection is competitive and subject to GSU committee decisions.
7. Only one award can be availed at a given time.

Eligibility Criteria

- Applicant has held a minimum cumulative GPA of 3.5 or above on the scale of 4.0 in UDST Bachelor's Degree.
- Applicant is a Resident of Qatar.
- Applicant holds a bachelor's degree from UDST.

- Applicant has attached the acceptance letter or conditional acceptance letter from UDST to be considered for the award.
- Applicant has attached a Statement of Justification (350-400 words).
- Academic Transcript for UDST's bachelor's degree.
- Applicant has attached a Reference letter.
- Applicant has attached Current CV
- Applicant has attached copy of valid QID
- Applicant has attached Salary Certificate & Last 3 months Bank Statement
