2. Please submit all supporting documents in accordance with the eligibility criteria.
3. Provide accurate and verifiable information. Incomplete applications may be disqualified.
4. Student must retain a minimum cGPA of 3.5 and satisfactory disciplinary standing throughout the master's program to retain the award.
5. Application can be submitted any time after receiving the full or conditional acceptance letter, including after the program has commenced.
6. Financial incentives follow UDST's Teaching Assistant (TA) policy, procedures, and guidelines.
7. Submission does not guarantee award. Selection is competitive and subject to GSU committee decisions.
8. Only one award can be availed at a given time. Upon acceptance, a Graduate Teaching Assistantship (GTA) takes precedence over a tuition waiver and supersedes it.
9. Applicants must submit completed applications and all supporting documents to GSU.Incentives@udst.edu.qa

Eligibility Criteria

- Applicant has a minimum GPA of 3.5–4.0, based on their most recent degree (e.g., Bachelor's) or current Master's cGPA if already enrolled.
- Applicant is not employed full-time at the time of application.

- Most Recent Academic Transcript
- Applicant has attached a Statement of Justification (350-400 words)
- Applicant has attached a Reference letter
- Applicant has attached Current CV
